Guidelines for Article Contributors

- 1. **Journal on English as a Foreign Language (JEFL)** accepts articles touching the ground of English language teaching and learning with insights from applied linguistics, literature, and related academic disciplines, which have not been published or are under consideration elsewhere.
- 2. Manuscript must be sent through JEFL online system (OJS) available at http://e-journal.iain-palangkaraya.ac.id/index.php/jefl.
- 3. Checklist for JEFL article contributor must be emailed **to** jefl@iain-palangkaraya.ac.id while you are submitting manuscript via JEFL Online System (OJS).
- 4. Articles will be reviewed by subject reviewers, while the editors reserve the right to edit articles for format consistency without altering the substance.
- 5. JEFL is an open access international journal. Every article submitted to the journal editor is free of charge (free no page charge) including free article processing fees.
- 6. Manuscripts should be typed in MS Word doc. format; using 12-pt Palatino Linotype font; left, right, top, and buttom margins are 3 cm; single-spaced on A4-sized paper; 15-20 pages in English or about 6000 words (excluding References); containing the importance of the topic, the gap between theory and practice or between reality and expectation, or lacks of studies, objectives of the present study, method, findings, and conclusion.
- 7. Research-based article must follow the template. It should contain: (a) Title, which must be consice and informative; (b) Full name of contributor(s) without academic title(s), email address written below the name, affiliation and affiliation address; (c) Abstract (maximum 200 words), clear and informative, which should contain the purpose, methodology, and findings of the study; (d) 3-5 Keywords, which are well selected and closely related to the topic; (e) Introduction without heading, which includes review of related literature and research purpose in essay style; (f) Method; (g) Findings; (h) Discussion; (i) Conclusion (and Suggestion); (j) References; and (k) Appendix, if any.
- 8. Conceptual article must follow the template. It should be organized as follows: (a) Title, which must be consice and informative; (b) Full name of contributor(s) without academic title(s), email address written below the name, affiliation and affiliation address; (c) Abstract (maximum 200 words), clear and informative; (d) 3-5 Keywords, which are well selected and closely related to the topic; (e) Introduction without heading; (f) Body Text (subtitle when necessary); (g) Conclusion (and Suggestion); and (h) References.
- 9. The title of paper should not exceed 12 words, bold, centered, with Palatino Linotype 14 font.
- 10. An abstract not exceeding 200 words, in one paragraph, in Palatino Linotype 12, line spacing 1, and with no references, must appear on the top of the first page after the title of paper, the name of author, the author's email, the author's affiliation, and the affiliation address.

- 11. The abstract should be clear and informative. It should contain the purpose, methodology, and findings of the research. Keywords must be well selected and closely related to the topic to facilitate reader's search; it must be 3-5 keywords. Next, "How to cite this paper" is placed below the keywords.
- 12. The introduction should clearly state the purpose of the paper. It should include key references to appropriate work, and it should state the significant contribution of the research. All introductions should be presented in the forms of paragraphs, not pointers, with the proportion of 15-20% of the whole article length.
- 13. The method section consists of description concerning the research design, the population and sample or the subjects of the research, data sources, data collection, and data analysis with the proportion of 10-15% of the total article length, all presented in the form of paragraphs.
- 14. The findings and discussion section consist of description of the results of the data analysis to answer the research question(s) and their meanings seen from current theories and references of the area addressed. The proportion of this section is 40-60% of the total article length.
- 15. The conclusion section consists of the summary, restatement of the main findings. It should state concisely the most important propositions of the paper as well as the author's views of the practical implications of the result. Also, the suggestion can be stated in this section following the conclusion. The suggestion should be based on the findings, discussion, and conclusion.
- 16. The placement of the Figure is in the middle with the caption below is written in Palatino Linotype 11 font. The caption has to mention the title and the source of the picture.
- 17. The table must be typed, and consecutively numbered. The title is written above the table in Palatino Linotype 11 font, while the source is placed below the table in the same font.
- 18. Every source cited in the body of the article should appear in the reference, and all sources appearing in the reference should be cited in the body of the article.
- 19. The sources cited should at least 80% come from those published in the last 10 years. The sources cited are primary sources in the forms of journal articles and research reports, including thesis and dissertation. Citations from journal should be at least 80% of the total references cited.
- 20. Subheading system (except for the introduction):

LEVEL ONE: ALL CAPITAL, BOLD, LEFT JUSTIFICATION
Level Two: Capitals-lowercase, Bold, Left Justification

Level Three: Capitals-lowercase, Italic-bold, Left Justification

- 21. Quotation and references follow *American Psychological Association (APA) 6th edition* style.
- 22. It is suggested to use *Reference Management Software*, MENDELEY (http://www.mendeley.com) or ZOTERO (http://www.zotero.org).

23. References should be presented alphabetically and chronologically and be set to 12-pt Palatino Linotype font, justified, with a single line spacing and hanging indent.
